ADMINISTRATIVE ORDER NO. 12113

PRIVATE PASSENGER AUTOMOBILE INSURANCE

ESTABLISHMENT OF STANDARD FORMS OF POLICIES, RIDERS, ENDORSEMENTS, AND OTHER SPECIAL OR SUPPLEMENTAL AGREEMENTS AND PROVISIONS FOR USE BY ALL INSURERS IN INSURING (1) AGAINST LOSS OR DAMAGE RESULTING FROM ACCIDENT TO, OR INJURY SUFFERED BY, ANY PERSON, AND FOR WHICH THE PERSON INSURED IS LIABLE, (2) AGAINST LOSS BY LIABILITY FOR DAMAGE TO PROPERTY RESULTING FROM THE OWNERSHIP, MAINTENANCE OR USE OF ANY MOTOR VEHICLE, AND (3) AGAINST LOSS OF OR DAMAGE TO ANY MOTOR VEHICLE OWNED BY THE INSURED, PURSUANT TO THE PROVISIONS OF §§ 38.2-2218 TO 38.2-2223, INCLUSIVE, OF THE CODE OF VIRGINIA.

BY LETTERS DATED April 11, 2019 through August 20, 2020, came the applicant, Insurance Services Office, Inc., on behalf of their participating insurers, and filed with and requested the approval of the Commissioner of Insurance of the proposed new and revised ISO Personal Auto Policy form and related endorsements for adoption as standard automobile forms for use by all insurers in this Commonwealth, pursuant to the provisions of § 38.2-2218 of the Code of Virginia;

NOW, ON THIS DAY the Commissioner, having considered the recommendation of the staff of the Bureau of Insurance that the proposed filing is proper and not in conflict or inconsistent with the laws of this Commonwealth, is of the opinion, finds and orders:

(1) THAT the following 2018 Personal Auto Policy form and related endorsements are approved and hereby filed by the State Corporation Commission, Bureau of Insurance in its office at Richmond, Virginia:

(2) THAT, the following endorsement, previously approved by Administrative Order 12110 effective July 1, 2020, remains a standard form for use with the 2018 Personal Auto Policy program:

(3) THAT, except as hereinafter provided, the aforementioned 2018 Personal Auto Policy form and related endorsements shall become standard forms **available** for use by all insurers applicable to all policies effective on and after January 1, 2021; and

(4) THAT, for all insurers issuing policies of motor vehicle insurance as defined in Virginia Code § 38.2-2212, the 2018 Personal Auto Policy form and related endorsements shall become the **only** standard forms and **must be used** by all insurers for policies effective on and after January 1, 2022; and thereafter no insurer shall use any forms covering substantially the same agreements provided for by such standard forms, unless they are in the precise language of the standard forms.

IT IS FURTHER ORDERED,

(1) THAT if there is objection to the provisions of any of these standard forms, the objection must be filed in writing within twenty days from the date upon which this Order is entered. If written objection is filed, these forms shall not become available as standard forms as provided herein and proceedings in reference thereto shall be instituted, and

(2) THAT the Bureau of Insurance shall immediately notify all parties to whom attested copies of this Order are directed, in writing, upon receipt of an objection from any insurer as to the provisions of any of these standard forms.

IT IS FURTHER ORDERED,

(1) THAT there being, in the opinion of the Commissioner, no further necessity for the continuance of the following standard forms, they are hereby withdrawn for policies effective on and after January 1, 2022:
