ADMINISTRATIVE ORDER NO. 12165

Private Passenger Automobile Insurance

Establishment of certain standard automobile insurance forms pursuant to §§ 38.2-2218 through 38.2-2223 of the Code of Virginia

By correspondence dated February 15, 2023, the applicant, Insurance Services Office, Inc., filed with and requested approval of forms for adoption as standard automobile forms for use by all insurers writing motor vehicle insurance in Virginia, pursuant to § 38.2-2218 of the Code of Virginia.

Now, the Commissioner of Insurance, having considered the recommendation of the staff of the Bureau of Insurance that the proposed filing is proper and not in conflict or inconsistent with the laws of Virginia, finds and orders that:

- (1) the following standard forms are approved for use with the 2018 Personal Auto Policy, and are hereby filed by the State Corporation Commission (Commission), Bureau of Insurance:

PP 14 03 07 23 Uninsured Motorists Coverage – Virginia and

PP 14 34 07 23 Uninsured Motorists Coverage (Alternative Coverage) - Virginia

- (2) for policies effective on and after July 1, 2023, all insurers issuing policies of motor vehicle insurance as defined in § 38.2-2212 of the Code of Virginia must use standard forms PP 14 03 07 23 Uninsured Motorists Coverage – Virginia and PP 14 34 07 23 Uninsured Motorists Coverage (Alternative Coverage) – Virginia;
- (3) on and after July 1, 2023, no insurer shall use any form covering substantially the same agreements provided for by such standard form, unless the form is in the precise language of standard forms PP 14 03 07 23 Uninsured Motorists Coverage – Virginia and PP 14 34 07 23 Uninsured Motorists Coverage (Alternative Coverage) – Virginia;
- (4) any objection to the proposed forms must be filed with the Commission within 20 days after the entry of this Order;
- (5) the Bureau of Insurance shall notify all parties to whom attested copies of this Order are directed upon receipt of any objection to the proposed forms;
- (6) in the opinion of the Commissioner there is no further necessity for the continuance of form

PP 14 03 10 20 Uninsured Motorists Coverage – Virginia,

and it is hereby withdrawn for policies effective on and after July 1, 2023; and

- (7) attested copies of this Order be sent to all insurers and rate service organizations licensed to write motor vehicle insurance, the Virginia Automobile Insurance Plan, and the Deputy Commissioner of Insurance of the Property and Casualty Division.
