


## Withdraw a Foreign Corporation in the Clerk's Information System

A foreign stock or nonstock corporation authorized to transact business in Virginia can be voluntarily withdrawn online. To do so, you can file an Application for a Certificate of Withdrawal. This how-to guide will walk you through withdrawing a foreign stock or nonstock corporation online in the new Clerk's Information System (CIS) <a href="https://cis.scc.virginia.gov/">https://cis.scc.virginia.gov/</a>.

- Log on to CIS at <a href="https://cis.scc.virginia.gov/">https://cis.scc.virginia.gov/</a>.
  - Note: Google Chrome, Internet Explorer or Microsoft Edge are recommended.
- 2 Click Online Services on the top left.
- Under Business Entities, click Existing Foreign Businesses.
- Make sure the Foreign Entity radio button is selected. Then, select Stock Corporation or Nonstock Corporation from the dropdown.
- 5 Select Application for Certificate of Withdrawal from the drop-down.
- 6 Click Continue.
- Enter either the Entity Name or the Entity ID number and click Search.
- 8 Click the **Select** button next to your business' name. DO NOT click the green entity name.
- Click Continue.



## Withdraw a Foreign Corporation

- Review the **Entity Information**. If needed, update the Entity Email Address and/or the Contact Number and click Next.
- Complete all fields marked with an asterisk 11 (\*) in the Mailing Address for Process section and click Next.
- **OPTIONAL:** Upload Application for 12 Certificate of Withdrawal. Check the The uploaded document will act as the filing image radio button.


Click **Attach** and select the file you want to upload.


Note: If you upload a document, your submission will not be approved in real-time, but instead will be reviewed by the Clerk's Office.

- Click Next.
- Indicate if you are signing as an Individual or On Behalf of Business Entity by checking the appropriate radio button.
- Complete all fields marked with an asterisk (\*) in the **Signature Information** section and click Add.
- Click **OK** in the pop-up box.
- Click Next.









## Withdraw a Foreign Corporation

- Review each section of the **Application for Certificate of Withdrawal**, and make any edits, as needed.
- Click Add To Shopping Cart.
- Click Checkout.
- Click Go To Payment.
- In the Confirmation pop-up window, click I Agree.

Note: You will be taken to a site administered by LexisNexis to complete your payment.





- Enter your **Billing Address** and **Payment**Information, completing all fields marked with
  an asterisk (\*). You must complete the **Captcha**field.
- Click Continue.
- Check the **Acknowledgement** radio button and click **Pay Now**.

Note: Do not close the browser window.
