COMMERCIAL AUTOMOBILE INSURANCE

ESTABLISHMENT OF STANDARD FORMS OF POLICIES, RIDERS, ENDORSEMENTS, AND OTHER SPECIAL OR SUPPLEMENTAL AGREEMENTS AND PROVISIONS FOR USE BY ALL INSURANCE COMPANIES IN INSURING (1) AGAINST LOSS OR DAMAGE RESULTING FROM ACCIDENT TO, OR INJURY SUFFERED BY, ANY PERSON, AND FOR WHICH THE PERSON INSURED IS LIABLE, (2) AGAINST LOSS BY LIABILITY FOR DAMAGE TO PROPERTY RESULTING FROM THE OWNERSHIP, MAINTENANCE OR USE OF ANY MOTOR VEHICLE, AND (3) AGAINST LOSS OF OR DAMAGE TO ANY MOTOR VEHICLE OWNED BY THE INSURED, PURSUANT TO THE PROVISIONS OF SECTIONS 38.2-2218 TO 38.2-2223, INCLUSIVE, OF THE CODE OF VIRGINIA.

WHEREAS, Pursuant to the provisions of Sections 38.2-2218 to 38.2-2223, inclusive, of the Code of Virginia, the State Corporation Commission Bureau of Insurance, by other Administrative Orders, has established certain forms of policies, riders, endorsements, and other special or supplemental agreements and provisions for use by all insurance companies in insuring (1) against loss or damage resulting from accident to, or injury suffered by, any person, and for which the person insured is liable, (2) against loss by liability for damage to property resulting from the ownership, maintenance, or use of any motor vehicle, and (3) against loss of or damage to any motor vehicle owned by the insured;

WHEREAS, in response to the Bureau of Insurance request, in response to <u>Virginia Supreme</u>

<u>Court ruling in Virginia Farm Bureau Mutual Insurance Company v. Williams</u>, 677 S.E.2d 299 (Va. 2009)

several Virginia-Specific Declarations are being withdrawn.

AND IT APPEARING to the Commissioner of Insurance that these standard Virginia-Specific Declarations adopted for use in writing the types of insurance herein referenced should no longer be continued;

IT IS, THEREFORE, ORDERED, that there being, in the opinion of the State Corporation Commission Bureau of Insurance, no further necessity for the continuance of the following Virginia-Specific Declarations, that they be withdrawn for use with policies effective on or after August 1, 2011:

CA DS 22 03 06 - Virginia Business Auto Declarations

CA DS 24 08 08 - Virginia Garage Declarations - Dealers

CA DS 27 03 06 - Virginia Truckers Declarations

CA DS 35 03 06 - Virginia Motor Carrier Declarations

IT IS FURTHER ORDERED, that attested copies of this order be sent to all licensed rate service organizations, Mary M. Bannister, Deputy Commissioner of Insurance, and all companies which are affected thereby.
